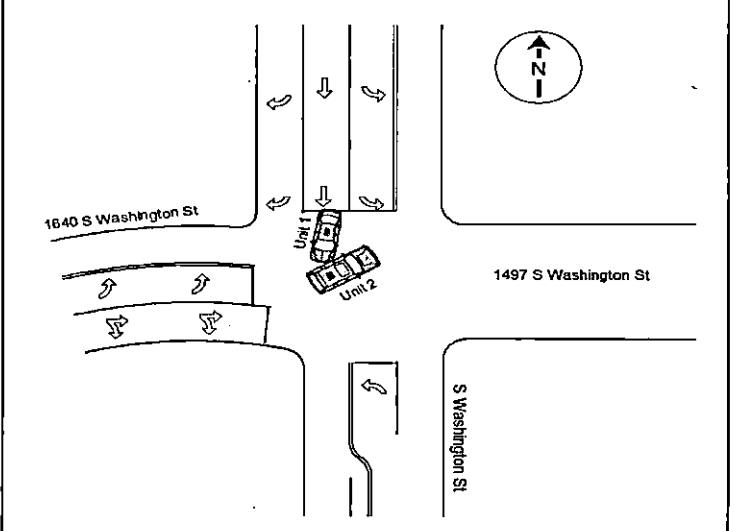

Unit 01 slid through the intersection and tried to turn to avoid striking Unit 02. Unit 01 struck Unit 02 in the driver side. Unit 02 stated he tried to gas it and swing wide to try to avoid the crash but it did not work. Finneys was utilized to winch Unit 02 off a curb.
