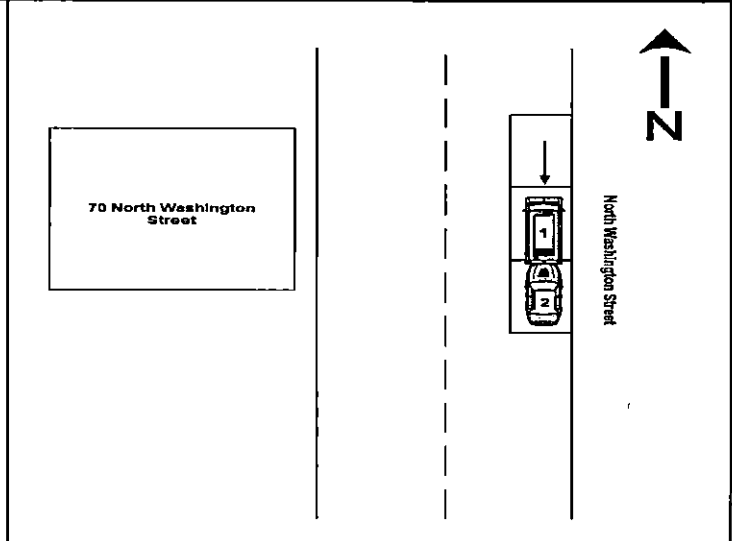

NARRATIVE  
Unit 2 was parked in the south most parking space on North Washington Street when Unit 1 was parked in the parking space directly north of Unit 2. Unit 1 was trying to get out of their parking space and backed into Unit 2. Security camera footage was checked at Ace Hardware which is where the crash occurred in front of and there is no footage towards the roadway where the crash took place, so there is no way to identify Unit 1.

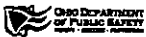
