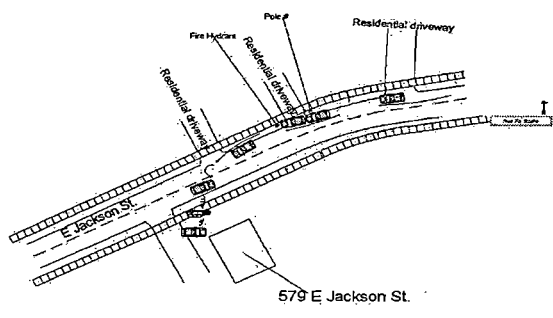

NARRATIVE

Unit 01 was traveling West when it went off the roadway at a residential driveway (612 E Jackson St.) on the North side of the road. After traveling in the tree lawn for 73.2 feet the vehicle struck pole # A3355625 with its passenger side mirror and continued on through another driveway. Unit 01 then struck a Fire Hydrant throwing it 33.3 feet onto the sidewalk. Unit 01 continued with its passenger side tires off of the roadway for another 49 Feet until reentering the roadway by jumping the curb. When entering the roadway the brakes were depressed causing mark on the road as the vehicle spun counter-clockwise into the curb on the south side of E Jackson st now facing East. At this point the passenger side tires made contact with the curb causing the vehicle to flip to its top and in the yard of 579 E Jackson st. Unit 01 then flipped back on to its tires facing East where it came to its final rest.
