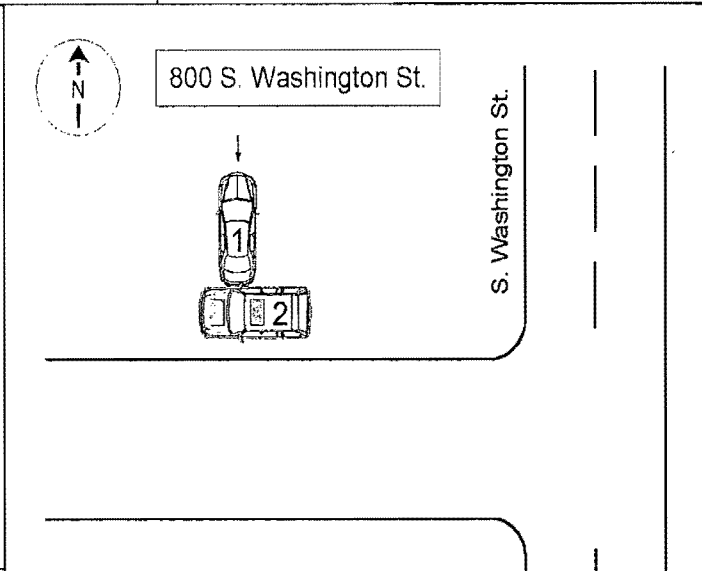

Unit 2 was parked in a parking lot directly behind Unit 1. Unit 1 then attempted to reverse and struck Unit 2.


