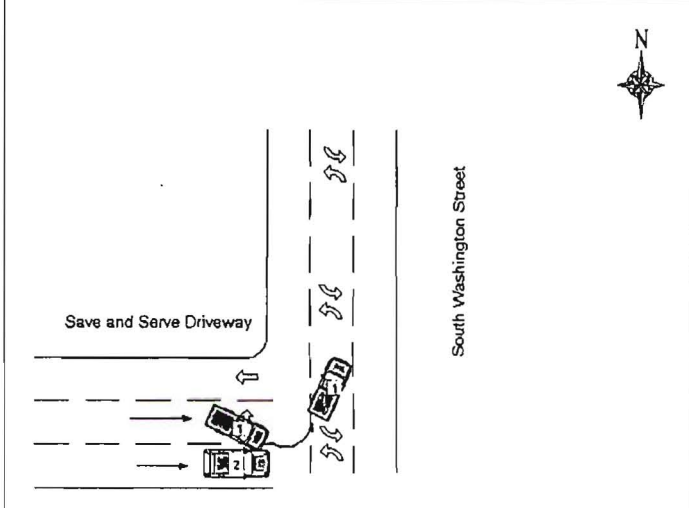

NARRATIVE

Unit 1 was waiting in the left turn lane to make a left turn out of Save and Serve's driveway to head northbound on S. Washington St. Unit 2 was approaching S. Washington St. in the right hand turn lane and was slowing down next to unit 1. As unit 2 approached the road unit 1 did turn right into unit 2 striking unit 2's bumper. The driver of unit 1 kept driving and scratched the majority of the passenger's side of his vehicle. Unit 2 only had paint transfer on his driver's side bumper. Due to the collision taking place on private property no one was issued a traffic citation.

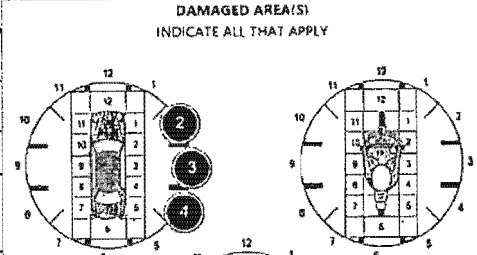

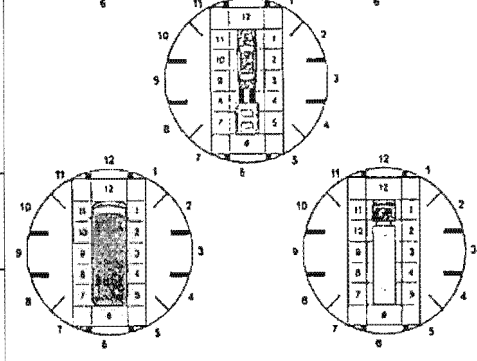

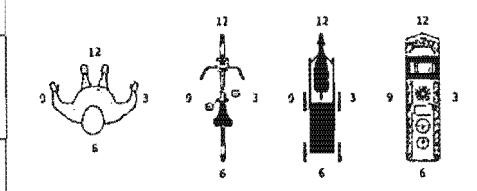
