NARRATIVE Unit 01 was traveling northbound on Port Washington Rd. and was unable to make it up the hill due to the icy conditions. Unit 01 started to back down the hill when another vehicle came up behind Unit 01. Unit 01 then moved over into the southbound lane to continue backing down the hill. At that time Unit 02, who was traveling southbound on Port Washington Rd., came around the curve and saw Unit 01 in his lane of travel. Unit 02 went off the left side of the road to avoid striking Unit 01 and the other vehicle. As a result Unit 02 struck the embankment and a speed limit sign, and then came back out onto Port Washington Rd.
