Unit 01 started to go left of center into oncoming traffic, but got the vehicle turned to go back to the right. As he did that he struck Unit 02 in the right rear corner with the left side of his vehicle. Unit 01 then struck the curb on the right side of the road going over the curb, onto the sidewalk, and struck two parked trucks, Units 03 and 04, in the lot for Village Motors.</p>


