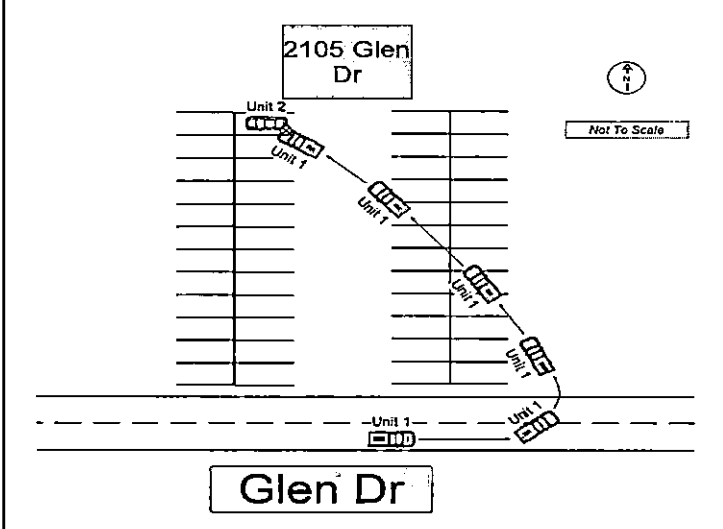

Unit 1 was driving eastbound on Glen Dr and turned left into the parking lot of 2105 Glen Dr. Unit 2 was an unoccupied vehicle parked in a parking space. Unit 1 struck the parked vehicle from behind and kept pushing the vehicle until bystanders stopped him. Unit 1 was later confirmed to be under the influence of alcohol over the legal limit at a BAC of .206.
