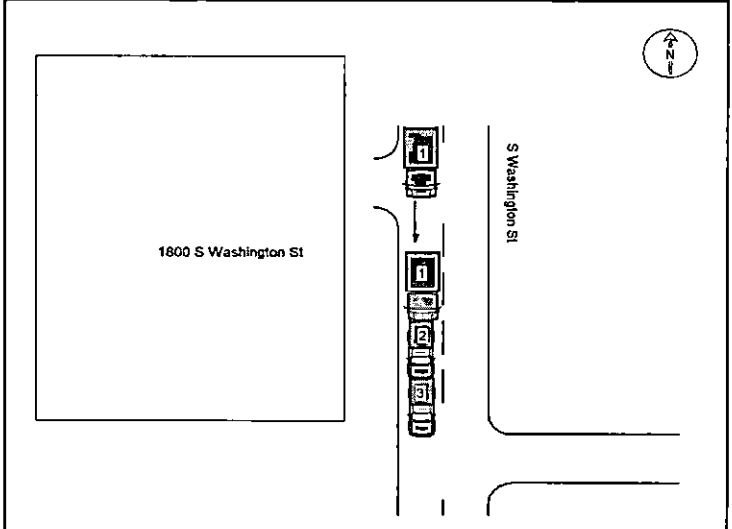

NARRATIVE

Unit #1 was south bound on S. Washington St. and failed to stop in time striking Unit #2 in rear which was stopped in traffic behind Unit #3 which was stopped in traffic waiting to turn into private drive. Unit #2 was pushed into rear of Unit #3. Unit #1 was towed from scene by Rigz Towing as driver indicated the brakes were malfunctioning at time of the accident. Unit #2 was towed from scene by Bully Dawg Towing from front and rear end damage. Unit #3 appeared to have a possible bent frame as the trailer hitch had been pushed in and down. Unit #3 will be taken for check up by a mechanic. Passenger of Unit #1 complained of pain across chest from seatbelt but denied treatment at time of report. Driver of Unit #1 had small laceration on finger from broken glass but he also declined medical treatment.
