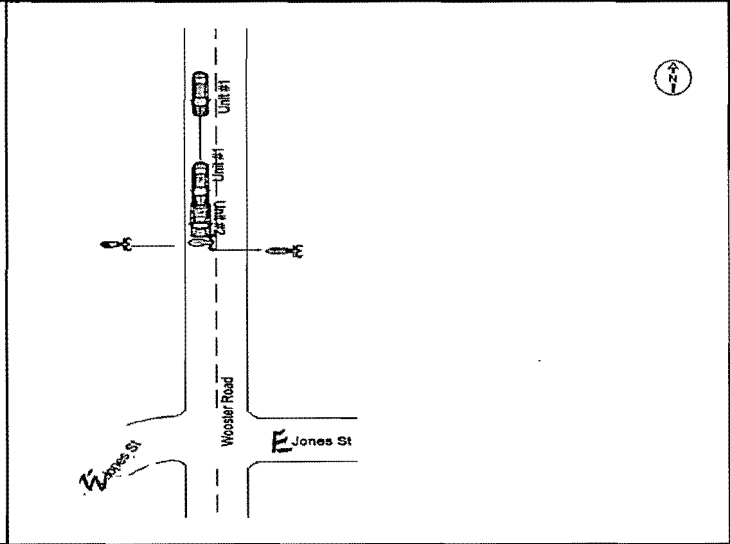

NARRATIVE  
On 02/01/2025 I was dispatched to a two vehicle non injury crash on Wooster Rd near Jones St. Upon arrival both units advised me that Unit #2 Struck a deer and upon braking, Unit #1 rear ended Unit #2. I was advised that the deer was still alive and fell into the Eastbound ditch on Wooster Rd. While on scene I dispatched the deer and the street department was advised. I then took the crash report to which Unit #1 vehicle was leaking fluids and had front end damage and unit #2 had heavy front end damage as well as rear end damage. Both vehicles were towed by Rigs towing company.

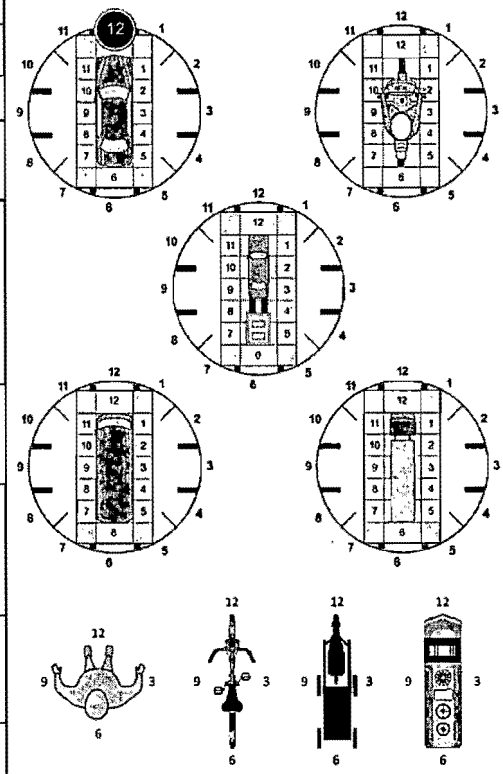

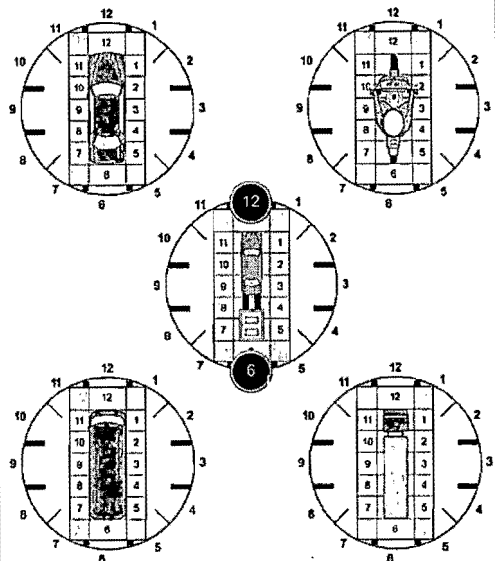

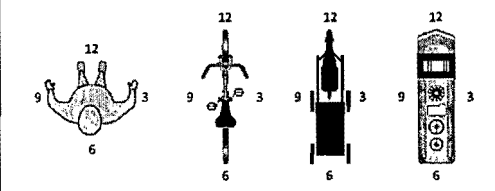
