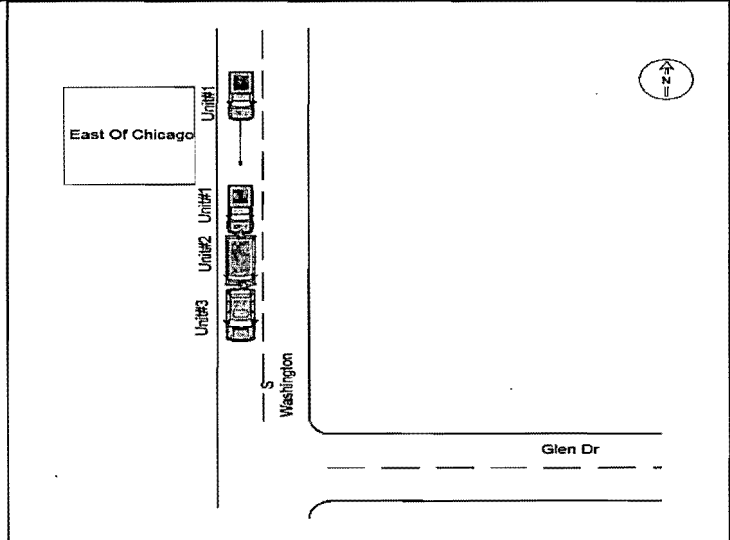

NARRATIVE  
On 03/11/2025 I was dispatched to S Washington St near East Of Chicago for a report of a four vehicle rear end crash. Upon arrival I gathered information from all four units and photographed the crash site. Unit #1 was transported to Pomerane Hospital for shoulder pain. Units two,three and four were all okay. Upon further investigation and speaking to a witness I discovered that this incident was two separate crashes. I also discovered that as Units two and three were stopped at the red light near the intersection of Glen Dr and S Washington Unit #1 rear ended Unit#2 causing unit #2 to strike the back of Unit #3's vehicle.
